Thank you for the opportunity to make a submission to the implementation review of the Planning and Design Code. I am hopeful that the expert panel will meet community expectations by listening attentively and acting on the feedback given.

Adelaide's inadequate tree canopy cover that is getting worse is concerning me greatly.

The impact of both the code and our poor regulations on tree canopy right across Adelaide is most concerning. You are no doubt familiar with the significant body of work published by the Conservation Council of SA and partner organisations over the last 2 years. Using an evidence-based approach, these reports highlighted how poor our laws have become since 2011 when significant exemptions were added to them, despite protests from both the community and experts.

The Conservation Council and partner organisations have compiled a list of their top ten priorities for reform. Support of these improvements will help make our state's tree regulations best practice, a Labor election practice. Many of the changes are backed up not only by the CCSA reports but also by the independent report commissioned by the State Planning Commission - I ask you to support these changes.

Trees play an important part of our daily lives. We need them more than they need us! By making the proposed changes you will improve our mental & physical health, clean the air that we breathe, remove carbon dioxide from the atmosphere, help cool our homes and streets, make our city more livable and mitigate the impacts of climate change for our children and grandchildren.

We need more of the natural environment in the city so everyone benefits from it.
