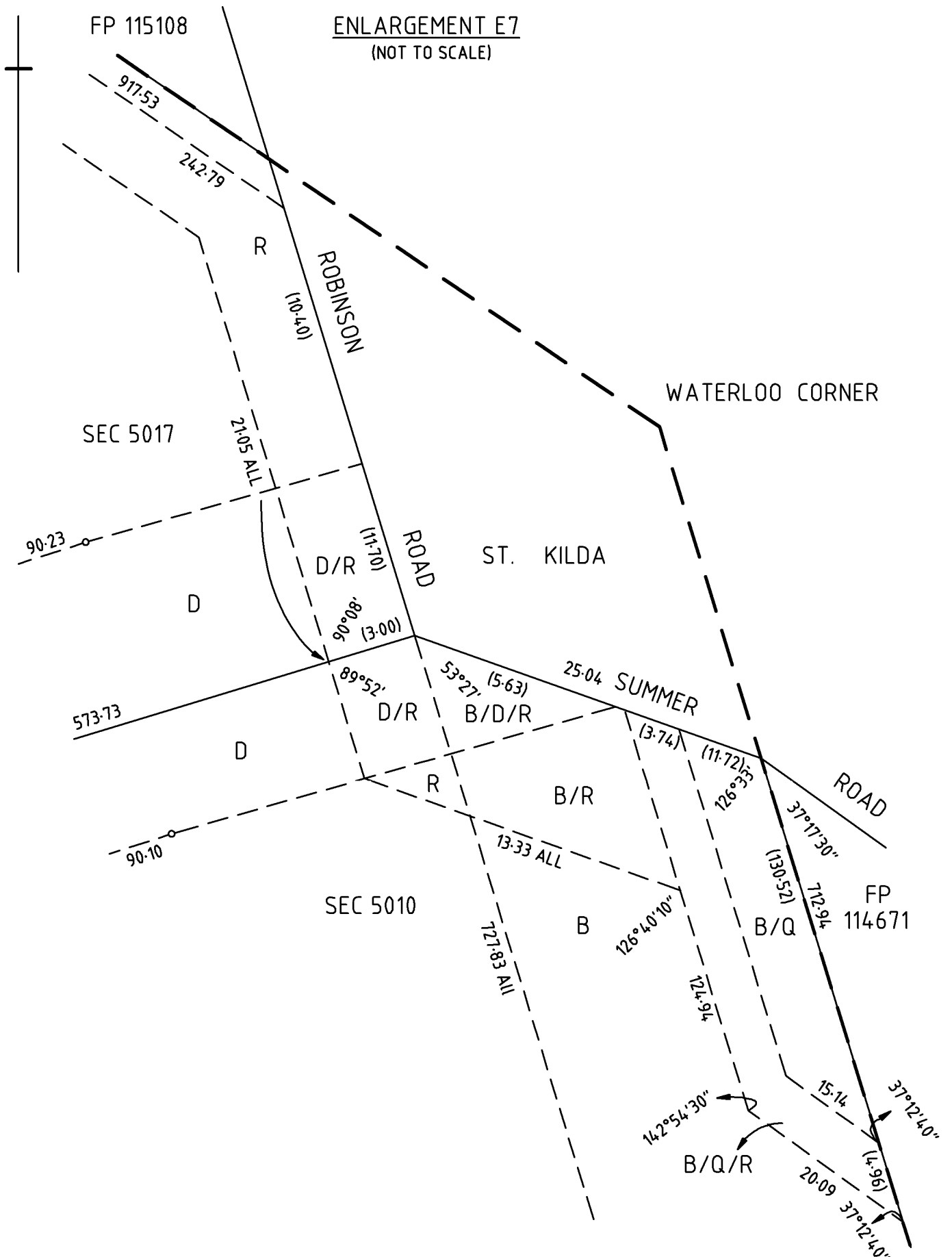








**ENLARGEMENT E6**
