## INKERMAN LANDFILL (NORTHWARD FILL) - RESOURCE RECOVERY CENTRE

## RELEASE OF AN AMENDMENT TO THE EIS FOR PUBLIC COMMENT

The Inkerman Landfill (Northward Fill) was approved by the Governor of South Australia on 21 January 1999 under *Development Act 1993* (having previously undergone an Environmental Impact Statement (EIS) level of assessment).

The landfill was commissioned in 2004 and is operated in accordance with an EPA licence to receive approximately 200,000 to 300,000 tonnes of waste per annum. The facility is owned by Cleanaway Waste Management Ltd (CWMS).

Pursuant to Section 114(2)(b) of the Planning, Development and Infrastructure Act 2016, CWMS has lodged an amendment to the EIS with the Minister for Planning and Local Government to modify the design and layout of the facility with the establishment of a waste management precinct under the 'Inkerman Resource Recovery Centre Masterplan' (IRRCM)

The IRRCM outlines a 10-year strategic plan for the processing of waste streams and organics at the site, to increase diversion from landfill and produce beneficial products either for reuse on-site or resale into commercial markets.

The proponent has now prepared an Amendment to the EIS, which has been released for public consultation from 26 January until 16 February 2022. The Amendment to the EIS describes the proposed changes to the landfill and the potential impacts associated with the Masterplan.
