



Future Pocket Park on Carroll Avenue

City of Port Adelaide Enfield Kaurna Country

The Future Pocket Park on Carroll Avenue Project received funding in the 2022-23 Open Space Grant Program, financed through the Planning and Development Fund.

Project Duration

This project is to commence from June 2023 with anticipated completion in June 2024.* *Grant recipients are provided 12 months to complete the land purchase. The project program and duration are subject to change.

Project Description

The land purchase seeks to increase open space provision in the suburb Kilburn, through the acquisition of four allotments approximately 3,000 square metres. The allotments are adjacent to Jack Watkins Reserve and it is anticipated that the future open space is combined with the existing Reserve, to improve access, movement and safety, as well as enhance the street appeal, amenity and recreation facilities on Carroll Avenue. The combined area of the proposed new and existing open space will total approximately 80,000 square metres. Key elements of the project include:

Increase the provision of open space to address access, safety, amenity and the environmental ✓ improvements specific to Kilburn

Create an open space that is accessible for all users by providing a well-designed space, ✓ inclusive of sustainable principles with additional shading and cooling through greening the

spaces and using water sensitive urban design

Establish an open space with play spaces, cycling and walking paths and seating for the local community to gather, play and rest

Enhance the sight lines, visibility and movement to and from Jack Watkins Reserve to provide safety and socal benefits for the community

Project Description

The land purchase seeks to double the size of the existing Elizabeth Ryan Reserve to approximately 1,200 square metres to provide an increase in quality open space with improved playground equipment and grassed areas. Key elements of the project include:

- Respond to high density development occurring in the northern suburbs of the City of Marion, by enabling the provision of quality open space and opportunities for play, recreation, fitness activities and non-organised sport
- ✓ Renew the land to create an accessible and diverse open space that contributes to neighbourhood character and provides for active living and community engagement
- Support the principles of Council's open space policy by providing the community with access to open space within proximity to residential areas
- ✓ Increase greening and tree canopy cover, as well as irrigated turf, suitable for seating and leisure activities
