

NOTICE

Planning, Development and Infrastructure (General) Regulations 2017

Schedule 6A, Clause 1(2)

Preamble

Schedule 6A, Clause 1(1) of the Planning, Development and Infrastructure (General) Regulations 2017 (the Regulations) makes the following accepted development:

- the construction or placement of a temporary building or structure on land within a designated area to be used as accommodation for a period not exceeding 2 years by persons employed or engaged in designated work.

Schedule 6A, Clause 1(2) of the Regulations provides that a designated area is an appropriate area designated by the Minister for Planning by notice on the SA Planning Portal and designated work is work of a kind also designated by the Minister for Planning by notice on the SA Planning Portal.

Notice

I, NICK CHAMPION, Minister for Planning, designate the following areas as designated areas for purposes of Schedule 6A, Clause 1(2) of Regulations:
