BUCKLAND PARK RESIDENTIAL DEVELOPMENT (RIVERLEA) – EIS AMENDMENT FOR CHANGED STAGING OF DEVELOPMENT AND ROAD CLOSURE

Release of Environmental Impact Statement Amendment for public comment

Walker Corporation P/L has approval to develop Buckland Park (Riverlea) for residential/ commercial development Five precinct areas are proposed. Precinct 1 has already received detailed land division approval.

Walker Corporation P/L has applied to change its approval to amend the subsequent staging such that development in the second precinct is focussed in the northern part of the site (i.e up to the Gawler River), before the western part of the site as was originally proposed.

An amendment to the Environmental Impact Statement (EIS), pursuant to the Development Act 1993, has been prepared by Walker Corporation P/L to describe the changes to the staging and to evaluate its potential environmental, social and economic effects.

This proposed amendment also includes the closure of Buckland Road between the Gawler River in the north and its intersection with Legoe Road in the south. This section is unmade and is physically part of the adjoining paddocks. This road closure would be implemented under Section 34 of the *Roads (Opening and Closing Act)* 1991.

The Minister for Planning will now assess the proposal.
