# What happens next?

### Cancellation request submission confirmed

An email confirming the submission of the development authorisation cancellation request is sent to the applicant, primary contact and the relevant authority that issued the application development approval.

### Request to cancel development authorisation is declined

If the relevant authority has determined the request is not to be actioned a 'Cancellation request declined' email is sent to the applicant and primary contact and the application's development approval remains in place.

### Request accepted and the development authorisation cancelled

When the relevant authority has accepted the cancellation request a 'Notice of Cancellation' email is sent to the applicant and primary contact.
