# **Southern Launch Capability Statement**

# **Business Overview**

Southern Launch is a SME business headquartered in Adelaide, South Australia. At its core, the company is comprised of space industry and ex-Australian Defence rocket experts with surrounding support functions.

Southern Launch is a rocket launch company and as such has a deep understanding of rocket design, integration, and operation. The company has developed a deep capability to manage all aspects of rocket launch activity from the international sourcing, shipment and storage of rocket motors, the design, navigating the regulatory environment, development and test of payloads that fly aboard the rockets and structures that make up the rocket, the assembly of rocket hardware before a launch, and ultimately the ability to safely undertake the launch of space capable rocket systems. No other company in Australia has that proven track record.

The company operates the Koonibba Test Range, a 145km overland rocket test range located in the Australian outback. The range allows Southern Launch to test fly rockets and payloads and recover the hardware after the launch. Southern Launch also operates the Whalers Way Orbital Launch Complex at the tip of Eyre Peninsula in South Australia. This site is used to undertake orbital launches out over the Great Australian Bight into polar, sun synchronous, and other high inclination orbits.

# **Key Skillsets**

Southern Launch has the following key skillsets:

- Rocket design
- Rocket hardware manufacture, assembly and test
- Sourcing, importing and storage of rocket motors
- Securing all launch and range permits to undertake safe rocket launches
- Rocket assembly at a range
- Range and flight safety analysis using ASTOS and the in-house developed MAGIC software suite

- Operating the Koonibba Test Range and Whalers Way Orbital Launch Complex
- Undertaking safe rocket launch activities

# **Overall Readiness**

Southern Launch recently undertook Australia's first civilian launches of space capable rockets from the Koonibba Test Range on 19 September 2020. On that date, Southern Launch safely flew two rockets to the edge of space for our customer DEWC Systems. Southern Launch acted as a Launch Service Provider to DEWC Systems with Southern Launch handling all activities related to the sourcing, import, storage and operation of the rocket and rocket test range. The launches demonstrated Southern Launch's ability to manage the entire processes involved in a launch event.

The company has undertaken rocket design contracts for the Australian Department of Defence as well as developed range safety analyses used to secure rocket launch permits from Australian regulators.

# **Setup for Success**

Southern Launch is an innovative company that has demonstrated its capacity to push beyond the abilities and expectations of other Australian companies and operate at the forefront of the world's space industry.

To further ensure the company delivers high quality outputs, Southern Launch is currently developing and implementing an ISO9001:2015 quality management system.

The company is customer driven with a strong history of delivering outcomes that push the boundary of Australian capabilities.

# Sovereign Capability

Southern Launch is an Australian owned and operated business, with two launch sites located in South Australia. The company works with Australian freight forwarders, specialist engineering firms, and indigenous organisations in relation to the operation and support of its ranges.

All Southern Launch staff must be eligible to hold and maintain an Australian Government security clearance, to a minimum of NV1.

The "2020 Defence Strategic Update & 2020 Force Structure Plan" confirms that access to space is critical to Australia's security. Therefore, the launch capabilities of Southern Launch are a vitally important sovereign capability for our nation.
