### Middleton Code Amendment

#### **Preamble**

The amendment instructions below reflect the proposed changes to the Planning and Design Code (the Code) as outlined in the Draft Code Amendment released for engagement. Changes were made to the Draft Amendment by the Designated Entity as a result of engagement (outlined in the Engagement Report furnished to the Minister for Planning by the Designated Entity under section 73(7) of the *Planning, Development and Infrastructure Act 2016* [the Act]) as follows:

Application of the Urban Tree Canopy to the affected area

The amendment instructions below reflect this change.

Pursuant to section 73(10)(d) of the Act, the Minister responsible for the Act has resolved to make the following alteration to the amendment furnished by the Designated Entity under section 73(7) of the Act:

Remove visual representation of 'proposed roads' from 'Concept Plan 131 Middleton'

The amendment instructions below incorporate this alteration pursuant to section 73(10)(d).

#### **Amendment Instructions**

The following amendment instructions (at the time of drafting) relate to the Planning and Design Code, version 2023.11 published on 3 August 2023. Where amendments to the Planning and Design Code have been published after this date, consequential changes to the following amendment instructions will be made as necessary to give effect to this Code Amendment. The Minister specifies under section 73(12)(c) of the Act that this Code Amendment will take effect on the day that it is deployed into both the electronic Planning and Design Code and the South Australian Property and Planning Atlas.

#### Instructions

Amend the Code as follows:

- 1. Spatially apply the Master Planned Township Zone (in place of the current Deferred Urban Zone) to the 'area affected' bounded by the blue line in Map A contained in Attachment A.
- Spatially apply the following Overlay to the 'area affected' bounded by the blue line in Map B contained in Attachment B:
  - Affordable Housing Overlay.
- 3. Spatially apply the following Overlay to the 'area affected' bounded by the blue line in Map C contained in Attachment C.
  - Urban Tree Canopy Overlay.
- 4. In Part 12 Concept Plans, under the section reltating to Alexandrina, insert new 'Concept Plan 131 Middleton' contained in Attachment D.


- 5. Spatially apply 'Concept Plan 131 Middleton' to the 'Concept Plan Boundary' bounded by the blue line contained in Attachment E within the Concept Plan Technical & Numeric Variations Layer of the SA Property and Planning Atlas.
- 6. In Part 13 Table of Amendments, update the publication date, Code version number, amendment type and summary of amendments within the 'Table of Planning and Design Code Amendments' to reflect the publication of this Code Amendment.








Proposed Urban tree canopy overlay
