Thank you for your quick response, and for the opportunity to provide the City of Port Lincoln's late submission for possible consideration by the expert panel members.

City of Port Lincoln Council wish to provide feedback on two particular areas of the review:

Appeal rights (refer Summary Paper 'Planning, Development and Infrastructure Act 2016')

Council wish to support the expert panel in exploring alternative or new third party appeal / review pathways, as currently for many planning assessments, once a determination has been made, third parties (eg neighbours) only have the ability to object / appeal a decision via the court. It is reasonable to expect that there may be some intermediate pathway in these instances, prior to needing to go to court.

• Carparking policy (refer Summary Paper 'Car Parking Policy in the Planning and Design Code')

Council wish to support the expert panel in reviewing policy on car parking, however noting that in areas such as Port Lincoln where there is no public transport, provision of car parking is a legitimate consideration for planning and any changes to this may further impact on demand for on-street parking and fall back to Council.
