

Engagement Plan: proposed amendment to State Planning Policy 1

Background information

Australia is currently experiencing a shortage of urban and regional planners. The shortage hinders South Australia's ability to tackle critical challenges including housing affordability, population growth, and the transition to a net-zero emissions future, whilst also placing the sustainability of our communities in jeopardy.

In response to this shortage, in January 2024 the Minister for Planning requested that the State Planning Commission initiate an amendment to the State Planning Policies (SPPs).

SPPs are the highest order policy document in South Australia's planning system. They guide planning and development in South Australia.

The aim of the amendment is to recognise the skills shortage and the importance of considering how the long-term vision for the state will be delivered and resourced.

The Commission determined that *State Planning Policy 1: Integrated Planning* (SPP1) is the most appropriate policy in which to incorporate the amendment. The Commission proposes to insert the following policy into SPP1 (Policy 1.12):

Provide an effective, efficient and enabling planning system that is well resourced with qualified professionals to support development, investment and good planning outcomes.

Other associated and complementary amendments are also proposed to ensure the language and intent of the new policy is consistently applied throughout SPP1.

The State Planning Policies introduced to the SA Planning system in January 2019 have held us in good stead through the preparation of the Planning and Design Code, driving much of the content for the overlays. The SPPs are also playing a critical leading role as we prepare the 7 new regional plans across the State.

Implementation of the SPPs, through both the preparation of the Code and the Regional Planning Program have found the SPPs to be comprehensive and robust and no further changes are proposed at this time, beyond changes proposed to SPP1.

Previous engagement

To date, no public engagement has been undertaken in relation to this policy amendment.

As part of preparing the proposed amendment, advice and input was sought from internal stakeholders in the Department for Trade and Investment's Planning and Land Use Services Division. Staff contributed their significant experience and knowledge of the State Planning Policies and the preparation and amendment of designated instruments.

Engagement purpose

The purpose of the engagement is to:

- ensure the proposed amendment to SPP1 considers and reflects the expectations of stakeholders and community
- educate and inform key stakeholders and the community about the policy amendment
- provide opportunities for stakeholders and the community to review the proposal, seek clarification and offer feedback on the proposal
- ensure compliance with the statutory obligations under the *Planning, Development and Infrastructure Act 2016* (the Act) and the Community Engagement Charter.

Engagement objectives

The engagement objectives are to:

- raise awareness across stakeholders and interested community regarding:
 - the proposed policy amendment
 - the opportunity to give feedback on the proposed changes
- provide appropriate and timely information and opportunities for stakeholders and community to give feedback on the proposed amendment
- respond to stakeholder questions and concerns during the consultation
- gather informed and relevant feedback from stakeholders and community that contributes meaningfully to the proposed amendment
- define the scope of consultation so that stakeholders know why feedback is being sought and how it will be used
- meet statutory engagement requirements
- 'close the loop' and inform stakeholders of the outcome of the consultation.

Scope of influence

Aspects of the project which stakeholders and the community *can* influence are:

- the inclusion of the proposed amendment in State Planning Policy 1.
- the language used in the proposed amendment to the State Planning Policy.

Aspects of the project which stakeholders and the community *cannot* influence are:

• which State Planning Policy the amendment will be applied to

- any of the other State Planning Policies (theses are not set forward for amendment at this time)
- any other content in State Planning Policy 1: Integrated Planning, unless it is related to or complimentary to the proposed amendment.

Key messages

State Planning Policies – general

- South Australia's 16 SPPs are the highest order policy documents in the state's planning system.
- SPPs guide the strategic direction of planning and how the planning system is used in SA.
- SPPs provide the policy framework for other planning instruments such as the Planning and Design Code, regional plans and design standards.
- The government can ensure that SPPs respond to modern challenges by updating them to include matters that are relevant to planning or development.

Current shortage of planning professionals

- Good planning is essential to South Australia's future, and the planners who shape our communities perform a vital role.
- There is currently a national shortage of urban and regional planners, highlighted in the Planning Institute of Australia's <u>Planners in Australia: State of the Profession Report</u> and in the Federal Government's <u>Skills Priority List</u>.
- The planning skills shortage is a critical concern for the state.
- South Australia needs qualified planning professionals so that we can deal with challenges like housing affordability, population growth, and the transition to a net-zero emissions future.
- A lack of planning professionals threatens the sustainability of our communities.
- Without enough skilled planning professionals, the delivery of SPPs, regional plans, and the broader planning system is at risk.
- The Minister for Planning's Built Enviroment Education Taskforce is creating new education opportunities to help address the skills shortage, but there is still more work to be done.

Proposed amendment to SPP1

- In response to the skills shortage, the State Planning Commission has initiated an amendment to the existing *State Planning Policy 1: Integrated Planning* at the request of the Minister for Planning.
- SPP 1: Integrated Planning coordinates the strategic use of land with necessary services and infrastructure. It influences how a city or region grows and creates livable and sustainable places that contribute to its prosperity.

• The proposed new policy (Policy 1.12) states:

Provide an effective, efficient and enabling planning system that is well resourced with qualified professionals to support development, investment and good planning outcomes.

- The proposed amendment addresses the long-term resourcing and provision of skills required to service SA's planning system.
- The proposed amendment aims to support and enhance SA's future planning capabilities.
- Increasing SA's planning capabilities will assist in delivering National Cabinet's new national target to build 1.2 million new well-located homes over 5 years. It will also lead to better and faster decision making on development proposals or implementing critical initatives such as rezoning land for housing or employment.
- Other associated minor amendments are proposed to ensure the language of the new policy is consistently applied throughout the SPP.
- The wording of the amendments was guided by the Objects of the Act in section 12 and the Principles of Good Planning in section 14 of the Act.
- No other State Planning Policies will be changed as part of this proposed amendment.
