In my view there are two critical factors to planning in SA:

1. be very clear and consistent about the criteria - once the criteria have been established there do not need to be any special considerations. Developers must know and understand that this is how it is, and propose developments accordingly
2. understand that Adelaide, in particular, has a unique and special character which should be celebrated and enhanced. That means that all development proposals should demonstrate how they either celebrate or enhance one of the extraordinary and significant aspects of Adelaide whether it be its unique settlement history, heritage, culture, social character, community spirit or its local and emblematic produce.

I am unable to attend the meeting but I would urge that power to approve planning proposals be based locally with City Councils as long as the criteria are properly established and consistently applied.
