## **Code Amendment Initiation Checklist**

## **Investigations and Consultation**

In determining whether to initiate a Code Amendment it is recommended that Proponents give early consideration to the key issues outlined in this Checklist to assist in determining what investigations and consultation will be required.

If any of the planning issues in this Checklist will apply to the land the subject of the proposed Code Amendment, refer to the Code Amendment Investigations Table for a detailed list of relevant investigations. It is also recommended that Proponents contact any relevant government agencies listed in this Checklist if their specialist information or assistance is required.

It is also strongly recommended that the Proponent seeks comments from the Council on the draft Proposal to Initiate a Code Amendment. If evidence of initial comments from the Council is not provided as part of the Proposal to Initiate, the Department will seek those comments on the Proponent's behalf.

The Department may also seek initial feedback from government agencies if their advice is required about the strategic assessment of the Proposal to Initiate, or to clarify investigations. This will not be required if this has been undertaken by the proponent, and evidence of this feedback is provided with the Proposal to Initiate.
