This infrastructure scheme proposal template has been prepared for the purposes of sections 163 and 164 of the *Planning, Development and Infrastructure Act 2016* to assist project proponents in preparing documentation for a proposals for the Minister for planning to initiate either a basic or general Infrastructure Scheme (or a combination of both).

- Basic Schemes applies for provision of basic infrastructure for a designated growth area.
- General Schemes applies for provision of essential infrastructure to facilitate significant development or urban renewal.

In deciding to initiate an Infrastructure Scheme the Minister for Planning must:

- Determine that the basic infrastructure is reasonably necessary for the purposes of develoment in a designated growth area and/or
- The infrasturcture will support, service or promote significant development within the designated growth area or facilitate development or urban renewal in a contribution area.
