Background information

- · Why is this Code Amendment being initiated?
 - The Affected Area (1 Walkerville Terrace, Gilberton), commonly known as the Buckingham Arms Hotel, comprises eleven (11) contiguous Certificates of Titles consisting of approximately 6,200m² bounded by Northcote Terrace and Walkerville Terrace.
 - The Affected Area is identified as a strategic 'gateway' site by State and Local Government planning strategies, reflecting the Affected Area's location on a major intersection, entry to the Town of Walkerville and edge of the Adelaide Park Lands.
 - The Affected Area is currently zoned Local Activity Centre under the Planning and Design Code, which envisages shops, offices, health and community facilities with a maximum building height of three (3) levels. The current zoning places a constraint on development and is inconsistent with the site's strategic 'gateway' description.
 - The Affected Area includes the Local Heritage listed Buckingham Arms Hotel, with this listing relating only to the external form, materials and detailing of the hotel, excluding later additions and alterations.
 - The landowner (the 'Designated Entity') has resolved to seek a rezoning to facilitate sensitive infill development in the form of mixed-use development. The proposed outcome seeks to accommodate medium density housing and complementary non-residential uses, compatible with the locality being a consolidated gateway site located on high-frequency public transport corridors.
 - The proposed Code Amendment does not propose to create any new planning rules. Instead, it
 is limited to the spatial application of the zones, subzones, and overlays with technical and
 numerical variations published under the existing Planning and Design Code.
- What does this Code Amendment hope to achieve?
 - The proposed Code Amendment seeks to re-zone the land to the Urban Corridor (Living) Zone.
 This zone will allow for mixed-use development with a residential focus, supporting medium density housing of up to 6 levels and compatible non-residential land uses.
 - A change in zoning will facilitate future land uses that are better aligned with the strategic 'gateway' identifier of the Buckingham Arms Affected Area in State and Local Government planning strategies.
 - The Code Amendment will facilitate future opportunities for increased residential densities, housing choice and a revitalised urban realm to enhance the amenity of the locality.
- Are there any existing strategies, reports or plans relating to the Affected Area shown in the Code Amendment? If so, what do they say?
 - The Code Amendment aligns with the State Planning Policy and 30 Year Plan for Greater Adelaide volume of the Planning Strategy, promoting a more compact urban form on transit corridors that can positively contribute to the public realm.
 - The former Department of Planning, Transport and Infrastructure (DPTI) Inner Metro Rim Structure Plan (2012) identified the Affected Area as a 'gateway to the city', warranting an increased concentration of activity and greater engagement with the Park Lands.
 - The Code Amendment addresses Local Government strategies, including both 2020-2024 Living
 in the Town of Walkerville and A connected Community the Town of Walkerville Urban

Masterplan (2020), which identify the Affected Area as an important arrival gateway and sought opportunities for increased residential densities, housing choice and revitalised urban realm.

- What have any past engagement processes (if known) identified about the Affected Area or any relevant adjacent or comparable areas?
 - The Town of Walkerville has been consulted and supports the intention to undertake a Code Amendment, subject to a review of the detailed investigations and Code policy to be provided as part of the engagement process.
 - The former Department for Planning, Transport and Infrastructure was consulted regarding the policy approach and the potential impacts from the rezoning on the surrounding road network.
 - Preliminary discussions were held with the adjoining owners at 14 Northcote Terrace, Gilberton, who have not indicated a firm opinion on the Code Amendment. However, this owner raised concerns about the loss of access to the Buckingham Arms carpark for their visitor parking, despite this access not being secured by any formal agreement or land deed.

Engagement purpose

The purpose of the engagement is to:

- Raise community awareness of the proposal to rezone the land.
- Inform the community of the desired outcomes and guiding policies contained within the Urban Corridor (Living) Zone, which has not been previously applied within the Town of Walkerville.
- Provide information about the proposed changes and what they will enable/mean for the affected locality.
- Enable the community to seek clarification and provide their feedback regarding the proposal.
- Close the loop for the community to understand the future decision made regarding the Code Amendment proposal, including how feedback from the consultation process was considered for incorporation.
- Ensure compliance with the *Planning, Development and Infrastructure Act 2016* and the associated Community Engagement Charter.
- Establish pathways for communication with the community and stakeholders, including the Town of Walkerville, State Agencies and Utility providers.

Engagement objectives

The engagement objectives are to:

- Ensure the community and stakeholders are aware that changes are proposed to the zoning of the Affected Area, specifically the shift from Local Activity Centre Zone to Urban Corridor (Living) Zone.
- Obtain community and stakeholder input and feedback concerning the proposed Code Amendment.
- Inform participants in the engagement process of the outcome and final decision concerning the proposal.

Scope of influence

Aspects of the project which stakeholders and the community *can* influence are:

- Whether the proposed 'Urban Corridor (Living) Zone' is the most appropriate zone for the Affected Area.
- Whether the proposed maximum height of up to 6 building levels, and up to 24.5 metres in height (with incentive policies that could allow for taller buildings) is appropriate for the Affected Area and surrounding context.
- Whether the investigations associated with the Code Amendment have appropriately addressed the following key issues:
 - Transport and parking impact;
 - Impacts on the values of a Local Heritage Place;
 - Stormwater impact;
 - o Interface impact (including noise, overshadowing and visual appearance); and
 - Infrastructure and servicing capacity and augmentation capability;
- Matters that may require further consideration/investigation before finalisation of the Code Amendment process.

Aspects of the project which stakeholders and the community *cannot* influence are:

- The geography of the Affected Area and the spatial extent of the Code Amendment proposal.
- The policies contained within the General Modules of the Planning and Design Code.
- The standard policies and wording contained in Zones and Overlays in the Planning and Design Code.

Key messages

The following messages will underpin the engagement regarding the Code Amendment:

- The Code Amendment proposes to change the zoning from Local Activity Centre Zone to Urban Corridor (Living) Zone. The proposed zone will allow for mixed-use development with a residential focus, supporting medium density housing of up to 6 levels and compatible non-residential land uses.
- The Urban Corridor (Living) Zone includes incentives for consolidated significant development sites
 that support increased development yield where a future development application can meet strict
 design criteria relating to management of off-site impacts and delivers broad community benefit
 including design quality, affordable housing or sustainability features.
- The proposed Code Amendment seeks to change the zoning of the land only. Separate development applications are required for any future development proposed on the land to address detailed issues relating to site access, carparking and design.
- The consultation will occur for a period of 6 calendar weeks
